



Workshop Permission Form

IMPORTANT INFORMATION - PLEASE READ

Indemnity - Workshops

This form must be completed and signed by the parent or guardian of all nominated Enrollees in a Jump StART Workshop under the age of 18 years.

Warning is given to the signatory of this indemnity that there is a risk of harm to the Enrollee and/or their property from participation in the Workshop. Those risks include but are not limited to; collisions, bruises, grazes, skeletal and spinal injuries through participation in theatre and physical theatre activities as indicated below.

- performing on a stage or in other areas;
- performing for other Enrollees;
- performances using props and musical instruments;
- physical interpretations of stories including physical contact with fellow Enrollees and tutors;
- games involving running in a confined space with other Enrollees;
- dancing;
- singing;
- other related theatre activities.

The Workshop means any workshop that includes interactive participation, lessons and performances, to be held from 1 January – 31 December 2020 at any Jump StART nominated venue.

'Enrollee' includes persons who pay, who are paid for by others, who do not pay or who have received a scholarship to participate in the Workshop.

I declare that:

1. (a) the Enrollee is medically fit and the Enrollee and I understand the physical demands of the Workshop;
- (b) there is no medical or health related reason why the Enrollee should not participate;
- (c) the Enrollee and I understand that the Workshop involves the possibility of injury;
- (d) the Enrollee and I understand that the Workshop involves the possibility of loss of or damage to personal possessions; and
- (e) the Enrollee and I understand that all applicable rules for participation must be followed and the sole responsibility for the Enrollee's personal safety remains with the Enrollee, including physical and emotional preparation and fitness to participate in the Workshop.

2. I agree to indemnify Jump StART for its loss in connection with all and any claim, right or cause of action which the Enrollee or the Enrollee's trustee, executors or administrators brings, whether in Australia or in a foreign country, against Jump StART for or arising out of illness or injury to the Enrollee, damage or loss of any description whatsoever and whether occurring in Australia or in a foreign country, including damages or loss resulting from another person's negligence or carelessness, which the Enrollee may suffer or sustain in the course of or consequent upon the Enrollee's participation in the Workshop, except insofar as I am unable to do so under statute.
3. The Enrollee and I understand that images (i.e. photographs) of the Enrollee participating in the workshop may be used in promotional material for Jump StART's website or future marketing materials, and we give approval to do so.
4. I have read and understood the terms and consequences of this Indemnity.
5. I give permission for the Enrollee to participate in the workshop.
